Two ERA-NETs: SUSFOOD2 & FOSC

The two networks launched a Joint Call for transnational research proposals based on the funds from participating countries in both networks and additional international partners.

ERA-NET Cofund SUSFOOD2

SUSustainable FOOD production and consumption

The scope of SUSFOOD covers the entire food supply chain, with the main focus on food chain sustainability beyond the farm gate. It covers processing, packaging, transport, retailing, food services, storage, and consumer activities.

26 partners from 15 European countries plus associated countries.

ERA-NET Cofund FOSC

Food Systems and Climate

The main challenge/aim of FOSC is to contribute to the achievement of food and nutrition security within the context of sustainable food systems, considering the three dimensions of sustainability (social, environmental, and economic).

27 partners from Europe, Africa, and Latin America.

The need to increase the sustainability and resilience of our food systems

II. Introduction to the Joint Call

Definitions

Sustainability of food systems is defined as a food system that:

- Supports **food security**,
- Makes **optimal use of** natural and human **resources**, and respects **biodiversity and ecosystems** for present and future generations,
- Which is **culturally** acceptable and accessible, **environmentally** sound and **economically** fair and viable, and
- Provides the consumer with **nutritionally** adequate, **safe**, **healthy** and **affordable** food.

Resilience is defined as the ability to:

- Better **resist stresses** and **shocks** and the capacity of this entity to bounce back rapidly from the impact.
- It entails the **capability to cope with a shock**, when it occurs, but also to be prepared **to adapt** better to a new situation.

II. Introduction to the Joint Call

Scope of the Call

- Strengthening research and development on **innovative solutions** for **resilient, climate-smart** and **sustainable food systems**, with a focus on approaches to improve **resource efficiency** and enhance the capability of food systems to withstand severe physical and economic **shocks**.
- Attaining a **transition** from current linear food production systems, which are vulnerable to system shocks, **to resilient circular systems** that encompass efficiency, side-stream valorisation and avoidance of food loss and waste and consider interdependencies.
- A progress in the **organisation and management** of food systems and **novel technologies** key to support the food systems transformation.

General Eligibility

- The application must be in **English**
- Min. of **three eligible independent legal entities** from a **min. of three different partner countries** (with funding in a specific topic)
- Applicants from non-participating countries or non-eligible applicants can participate on their own costs
- Max. duration of a project: **36 months**
- Max. requested total funding: **1.5 M€ per proposal**
- Total eligible budget per country/region **must not exceed 70 % of the total eligible project budget**

Project monitoring, meetings and reporting

- Partners from each funded project are expected to organise regular project meetings.
- Additionally, all coordinators should plan three mandatory joint network meetings (kick-off-, mid-term- and final meeting) in their project plan.
- Coordinators will be required to submit a mid-term and a final report to the funders about the results of their transnational project (in addition to reporting required by the national funding bodies).





Evaluation criteria

- **Excellence:** scientific quality of objectives; ambition in relation to the call scope and topic; innovative progress beyond the state-of-the-art.
- **Relevance and potential Impact:** coherence and pertinence of the objectives; contribution to the scope; potential to reach expected impact and innovations, embracing of cross-cutting issues, added value of transnational cooperation and geographical coverage; communication and dissemination to stakeholders; extent to which the outputs of the project will be relevant for, or contribute to, impacts on: Economic aspects, Environmental aspects, and Societal aspects.
- **Quality and efficiency of the implementation:** appropriateness and soundness of the research approach and methodology; quality, feasibility and effectiveness of the work plan; complementarity/competences/diversity of partners and disciplines; adequacy of the budget and balance between partners in terms of activities; appropriateness of the management structures and procedures including risk management; capacity building activities; soundness of the Communication, Dissemination and Exploitation Plan and valorisation and exploitation of the results; Data Management Plan; Ethics assessment.
